Mr. Beckles announced that we have arrived at mid-point in the year and that there are no significant changes to report. He continues to meet with the city regarding health benefits, and they are preparing a Request for Proposals for a medical plan using the city's plan, the school board's plan, and then a combined plan. Decisions on the combined plan were based on the parts of the plan that the city and schools thought would work best. Once the RFPs are received, they will be presented to the school board and the city council. The city and the schools are also investigating dental plans.

The student activity accounts have been examined at each school, and the manual for these accounts has been revised so that they are in compliance with regulations. The manuals will be reviewed by accountants to ensure that they are in compliance.

D. Student Representative Comments

Mr. Joel A. Graham, student representative for E. C. Glass High School, provided comments about the events and activities occurring at his school.

E-1. Textbook Adoption: History and Social Sciences – Secondary Level

The Code of Virginia states that local school boards shall be responsible for the selection and for the utilization of instructional materials. On October 18, 2011, the school board appointed an evaluation committed to plan, coordinate, and oversee the textbook adoption process for the purpose of presenting the adoption recommendations to the school board.

The evaluation committee for K-12 social sciences and K-5 reading/language arts textbook and instructional materials met in December and January. The evaluation committee along with secondary teachers and administrators has completed the review process and offers the attached recommendations for the school board to consider.

The evaluation committee considered textbooks and materials based on their correlation with the History and Social Science Standards of Learning, the quality of their content and ancillary materials, and their appropriateness for students. Parents from each school were also involved in the review. Additionally errata sheets and correlation reports provided by the Virginia Department of Education (VDOE) were reviewed by the evaluation committee.

Social sciences materials adopted now will be purchased for a six-year period beginning with the 2012-13 school year. During the 2011-2012 school year, textbooks and their ancillary materials will be delivered to the warehouse and organized for distribution in 2012-13, allowing teachers to have all materials in place on the first day of the school year. Secondary teachers will be professionally trained in the use of the textbooks and ancillary materials by selected publishers on February 20, 2012, a division-level professional development day.

The evaluation committee recommends the adoption of seven secondary textbook bundles for use with standard and advanced history and social sciences courses. All can be found on the VDOE recommended textbook adoption list. Furthermore, the committee recommends four advanced placement textbooks for use in advanced placement history and social sciences courses. A comprehensive list of these products appeared as an attachment to the agenda report.

There is \$339,083 in the FY2012 budget to pay for textbooks. The school board will need to request additional funding from the FY2013 budget to pay for the balance.

This item will be considered for action at the February 7, 2012, school board meeting.

F-1. Financial Audit for Fiscal Year Ended June 30, 2011

Brown, Edwards & Company, LLP, has completed the financial audit of the Lynchburg City Schools. Mr. Norman Yoder, senior associate of Brown, Edwards & Company, LLP, presented the financial statements to the school board. Because the school board agreed to receive a joint report with the City of Lynchburg beginning with the 2002-03 audit, there is no separate Comprehensive Annual Financial Report (CAFR) for school funds.

The school administration forwarded a copy of the City of Lynchburg CAFR, which includes information about the Lynchburg City Schools, the audit committee letter, and the management letter to the school board members. School board members and the general public may obtain additional copies of the report from the Department of Finance.

Further, the financial audit of the Lynchburg City Schools Activity Funds for the year ended June 30, 2011, has been completed, and Mr. Yoder presented the audit and cash basis financial statements to the school board.

The audit process began in August 2011, and the firm worked through November. The audit received a clean opinion, which was issued in late November. The audit process went very smoothly. This is the first time no material weakness was found, and there was no material audit adjustment. This should be noted and Mr. and Beckles and his staff are to be commended. Mr. Yoder stated that it is most important when the client staff understands numbers and they are capable of defending their numbers.

Mr. Yoder stated this is the first year of auditing the schools' activity funds, and there is no final draft of the audit at this time. He does have suggestions for tightening controls, and he will share those with the school administration.

F-2. School Board Policy 7-41: Use of Drugs and Alcohol

The school administration is reviewing school board policies and administrative regulations. As a result of that review, the school board policy regarding use of drugs and alcohol by students has been revised. A copy of the revisions to the policy appeared as an attachment to this agenda report. Language was added that will give the school board options when dealing with student discipline associated with this policy. Zero tolerance policies have weaknesses in that every case is different and the policies do not allow for school boards to have flexibility

with student discipline. The language that was added was obtained through VSBA policy services and has been reviewed by legal counsel.
