## **D-1. Efficiency Review**

Over the past several months, the superintendent has conducted an efficiency review of the Lynchburg City Schools. Dr. Massie's presentation focused on the following areas: academics, behavior management, athletics, custodial services, instruction and staffing, maintenance, and transportation.

Dr. Christopher D. Jones of Longwood University all of the schools within the division and prepared a report which he presented to the school board. Following his report, the school board convened a recess at 6:42 p.m.

The school board reconvened at 6:45 p.m.

Dr. Massie continued the review his findings for efficiencies in athletics, custodial services, instruction and staffing, maintenance, and transportation. A copy of the complete efficiency was presented to the school board.

## D-2. School Board Policy 7-33.3: Student Uniforms

Concern was raised about the opt-out portion of the policy and if this option, in effect, would do away with school uniforms. Dr. Massie explained that the opt-out portion of the policy makes it legally defensible and that it does not affect the integrity of the policy.
