H-2. Policy BBFA Conflict of Interest and Disclosure of Economic Interests

The Virginia School Boards Association (VSBA) recently released an update to policy BBFA Conflict of Interests and Disclosure of Economic Interests which has been reviewed by legal counsel and reflects the latest changes in state and federal laws and regulations. This policy revision appeared as an attachment to the agenda report. The most notable change was the addition of Section I regarding written opinions received from the local Commonwealth's attorney, city attorney, or the council that bars prosecution for a knowing violation of the Act provided the opinion was made after a full disclosure of the fact.

H-3. Lynchburg City School Board Policies and Administrative Regulations: Section 7 – Admissions

The process of converting the Lynchburg City Schools' (LCS) policies to the Virginia School Board Association (VSBA) format is ongoing process which has involved the conversion of entire sections of the LCS policy manual at a time. Periodically, recommended revisions to a LCS policy arise that warrant a conversion to the VSBA equivalent policy. Rather than delay the conversion of these policies until an entire section is converted, individual policies will be brought to the school board for conversion.

Policies related to admission requirements were presented to the school board for discussion. Mr. Copeland explained that the most notable changes were associated with employees and requirements for their children's school attendance zones and attendance for nonresident students. Currently, children of employees who live within the city must attend the school for which they are zoned. Children of employees who live outside of the city may attend any school that the employee would like for them to attend. Changes to the policy would allow the children of employees who live within the city within the city to have that option.

Current policy also allows individuals who live outside of the city to pay regular tuition and apply for special programs with additional tuition, such as the schools for innovation, the Gifted Opportunity Center, or the Central Virginia Governor's School for Science and Technology. Employees who live outside of the city may bring their students to Lynchburg City Schools tuition free, but they do not have access to the special programs. Changes to the policy would remove the ability for nonresidents to apply for special programs and allow nonresident employees to apply for the special programs, however, they would need to pay the additional charge.

H-4. 2016-17 School Calendar: Proposed Updates

On March 17, 2015, the school board approved the school calendars for the school division and Williams Marvin Bass Elementary School for 2015-16 and 2016-17. After implementing the 2015-2016 school division calendar, surveys were administered to staff and parents. Based on that feedback, three updates to the 2016-17 calendar are recommended. Those updates were shared during this presentation.

Surveys were administered in March to both staff and parents. There were 503 staff responses and 304 parent responses. Based on this feedback, the school administration offered the following suggestions for changes to the 2016-17 school calendar.

Intersession attendance days will be adjusted to occur on Monday through Wednesday. By moving the attendance days to the beginning of the break, students and staff will not have to adjust to coming back to school for Intersession after having multiple days off from school.

Early release days will be moved so that they are adjacent to other breaks in the calendar. By doing so, this will alleviate the "choppy" feeling to the calendar and provide longer breaks for students.

The dates for winter break will be modified from December 21, 2016 – January 3, 2017, to December 19, 2016 – December 30, 2016. This will provide two full weeks off for students and staff.

Questions were raised about moving the January 17 date to January 2 because high schools are moving to year-long courses. The school administration will review this item and provide information to the school board.
