## **B-3. Update on Schools Denied Accreditation**

The school administration provided information to the school board regarding the work in progress at Linkhorne Middle School and Thomas C. Miller Elementary School for Innovation, the two schools in the school division that were denied state accreditation this year.

Both schools offered information about their Professional Learning Communities and how teachers are collaborating to ensure that student achievement will increase. They have data driven conversations about individual students and share remediation ideas and strategies. They use COLET/LOLET aligned lesson plans with feedback from the principal and coach. Assessments are reviewed and aligned with the standards. Overall student achievement has increase at both schools.

## D. Student Representative Comments

Ms. Indya M. Page, student representative for Heritage High School, and Ms. Sidney M. Marshall, student representative for E. C. Glass High School, shared comments about the events and activities occurring at their schools.

## E. School Board Committee Reports

Ms. Carter shared information about the recent LAUREL School Board meeting indicating that a budget has been developed for the 2017-18 school year.

Mr. Polley provided information about the School Board Finance Committee meeting that occurred on May 4, 2017. Items discussed during the meeting were the school board policy regarding unpaid meal balances, school bus purchases, the 2016-17 fund balance plan, and health insurance premiums for 2017-18.

Mrs. Mason offered comments about the Governor's School Board meeting and stated that they are already making plans for the 2017-18 school year.

## F-1. Health and Wellness

The Lynchburg City Schools Department for Benefits is actively seeking ways to reduce costs for medical claims. The establishment of a wellness program is one way to help achieve this objective. The goal of the wellness program is to reduce the cost of medical claims by encouraging employees to take time to invest in their personal health and wellbeing. Representatives from the Department for Benefits shared some of the plans to encourage employee wellness which includes the use of an app that monitors healthy behaviors. A wellness committee will also formed that includes Wellness Champions from each location. The school division will also collaborate in physical activities with the city through softball, golf, bowling, volleyball, and kickball games.

#### F-2. Health Insurance Reserve

The actual health insurance claims for FY2016-17 are projected to exceed the budgeted amount this year. Through prudent planning, the school board has transferred funds from the school operating budget fund balance to a Health Insurance Reserve. This Reserve has accumulated \$1,640,608 and is to be used should claims exceed the budgeted amount in a given fiscal year. The school administration requested that the school board approve the transfer of \$1,300,000 from the Health Insurance Reserve held by the city of Lynchburg to cover the health insurance claims budget shortfall for FY2016-17.

# F-4. Policy JECZ Non-Resident Employee Student Tuition Waiver and JECZ-R Non-Resident Employee Student Tuition Waiver

Recently, the school board approved updates to Policy JEC-R School Admission. Those changes need to be reflected in other related polices, regulations, and forms. The following policies are being presented to the school board for review.

- JECZ Non-Resident Employee Student Tuition Waiver
- JECZ-R Non-Resident Employee Student Tuition Waiver

In addition, JEC-F Non-Resident Tuition Form has been part of school board policy. The school administration requests that this form be removed from policy so that minor updates can be made without being approved by the school board.

Information was provided about the number of students on the wait list for the schools for innovation. Mrs. Morrison stated that these students reside in the city of Lynchburg. These students should be given priority over students who reside outside of the city.

Dr. Brabrand explained that in an effort to keep highly qualified teachers at the schools for innovation, he is recommending the change to the policy so that those teachers who live outside of the city will be able to bring their children to the school where they teach. All other teachers in the school division who live outside of the city currently have this option. Teachers who teach at schools for innovation do not.

## F-5. School Operating Budget: 2017-18

As a result of the Lynchburg City Council adopting its 2018 budget, the school administration presented the school operating budget for 2017-18 for school board review. The review included proposed adjustments to revenue and expenditures based on funding to be received through state and local funding. Tier 1 items that will be funded are the LCS portion of the two percent increase for FY2018; the increase in retirement rate for VRS; the worker's compensation insurance increase; the annual rate increase for copy machine maintenance; the cost of background checks for volunteers; the employment of several special education teachers and support staff; the employment of an instructional assistant and alternative education teachers; and the increase in legal fees for the city attorney for school legal services. These items are all mandated costs in the amount of \$2,254,439.

Dr. Brabrand noted that this budget does not take us backwards as a school division, but it does not take us forward as aggressively as he would like. He stated that the school division needs resources if it is to improve.

The budget proposal includes a four percent increase in compensation for selected personnel: maintenance staff; bus drivers; bus assistants; and custodians. This is still short of the full market adjustment for these employees.

Dr. Brabrand has spoken with the city manager about revised salary scales for all employees. The city will be working with a consultant to conduct a salary study for its employees. The school division is also working to revised its current salary scales.

The school board will consider this item for action at its next school board meeting.
