#### C-1. Student Recognition

The Heritage High School Symphonic Band earned a Superior rating at the VBODA District VI Concert Band Assessment in March. The band received straight Superior ratings from the three-judge panel for their incredible performance as a part of the Grade V level of bands. With this Superior rating combined with their Superior rating as a part of the VBODA Marching Assessment in October, the Heritage High School band program has been named a Commonwealth of Virginia Honor Band for the 2014-2015 school year by the Virginia Band and Orchestra Directors Association. This is the 11th time that the Heritage band has been recognized by the VBODA with this distinction and the seventh time in the past 10 years.

### F. Student Representative Comments

Miss Angelica M. Walker, student representative for Heritage High School, and Mr. Jamison R. Spinner, student representative for E. C. Glass High School, shared comments about the events and activities occurring at their schools.

### G-1. School Operating Budget: 2015-16

During the school board meeting on May 5, 2015, the school administration presented information to the school board about the 1.5 percent salary supplement approved by the governor for instructional and support positions funded through the Standards of Quality (SOQ). This funding will provide market salary adjustment for tier two teachers, principals and assistant principals, bracket changes for coaches, and athletic trainer stipends. The school administration also provided information about the increase in insurance premiums for general liability and automobile insurance the school division will experience due to the poor loss performance of the account.

Following the presentation, the school board asked that the school administration provide details about the changes that will occur to the proposed budget for 2015-16. The school board also requested information about funding for field hockey at E. C. Glass High School. Mr. Beckles explained that the increase in insurance premiums will be transferred from fuel estimates projected for next year as it appears that fuel prices are stabilizing. He also reviewed the budget information that was provided to school board members. This information will appear in the budget document following school board approval of the budget for next year.

The school administration indicated that in order to fund field hockey at E. C. Glass High School, and item would need to be taken from the current Tier I recommendations. School board members discussed the priorities within Tier I as well as other factors that would preclude this item being included in the 2016-16 budget.

Upon MOTION by Dr. Nilles, SECONDED by Ms. Poore, the school board directed the school administration to budget field hockey as a Varsity sport at E. C. Glass High School and place this item as a Tier I item for the 2016-17 school operating budget.

### H-1. Lynchburg Beacon of Hope

During this presentation, Mrs. Laura L. Hamilton, executive director of the Lynchburg Beacon of Hope, will provided an update to the school board regarding the program. This information included activities that are occurring at the Future Centers, which are based at both high schools, and the goals and outcomes established for 2012-2015.

# H-2. School Nutrition Program: Summer Program

The School Nutrition Program is seeking school board approval to begin a program to provide free summer meals to children in several Lynchburg communities. The program is called the "School Food Service Program" and is administered through the Virginia Department of Health. Previously, students had been provided meals through 21st Century Community Learning Centers summer program grants. This funding is no longer available. Through research conducted by Mrs. Meryl T. Smith, director of school nutrition, she was able to find funding for students to receive both breakfast and lunch during the summer.

Using Linkhorne Middle School and Perrymont Elementary School as production kitchens, meals will be prepared for students in the school communities of Linkhorne Elementary School, Bedford Hills Elementary School, Perrymont Elementary School, and Linkhorne Middle School. Perrymont Elementary School and Robert S. Payne Elementary School will be open feeding centers. Students will be fed free of charge, and adults will be able to purchase meals for a nominal fee. It is the hope of the school administration to begin this program on June 15, 2015.

This item will be considered for action at the next school board meeting.
