F-1. School Board Retreat

The Lynchburg City School Board will conduct its annual retreat on July 18-19, 2013, at Lynchburg College. The superintendent has several items that he intends to present to the school board during that retreat. They are as follows:

Lynchburg City Schools Comprehensive Plan: Update Lynchburg City Schools' Educational Technology Plan: 2013-15 Beacon of Hope: Update Policy and Governance School Board Policy 7-51: Wellness Naming of Facilities School Board/Staff Communication School Operating Budget Calendar: 2013-14 Professional Development

Since the last school board meeting, school board members have had the opportunity to propose the following topics for discussion:

Superintendent's Evaluation Instrument Update on Pacing Guides Lead Coaches: Duties and Expectations Special Education: Process for Identifying Students with Special Needs Developmentally Delayed Program Elementary Alternative Education: Update on Reorganization and Student Selection Process

The school board and the school administration discussed topics that have been proposed. The school administration will draft an agenda for the two-day retreat and identify work sessions or school board meetings where items can be presented at a later date if there are too many items to review is such a short period of time.

The school board will review retreat items for a final time at the next school board meeting.

G-1. Lynchburg Beacon of Hope: Update

The Lynchburg Beacon of Hope opened Future Centers at E. C. Glass High School and Heritage High School this year. The mission of the Future Center is to provide tools and resources that will assist students in obtaining post-secondary education opportunities. Resources include financial aid, scholarship opportunities, college searches, test preparation, and tutoring. During this presentation, Mrs. Laura L. Hamilton, executive director of the Lynchburg Beacon of Hope, provided the school board with an update regarding the program's progress.

During this past year, the Beacon of Hope has capitalized on the two Future Centers by partnering with Paul Laurence Dunbar Middle School for Innovation to create college preparatory curriculum and a Future Fridays Series. At Linkhorne Middle School and Sandusky Middle School, the two schools collaborated with the Beacon of Hope to create a Map It curriculum, provide career exploration opportunities, college fairs, and Reality Checks. Further, there were more than 1,600 middle and high schools students introduced to Future Centers and college access programming, and more economically disadvantaged students were registered for SAT/ACT using fee waivers.

Future Centers and guidance staff worked together on projects such as College Application Day, and FAFSA completion increased the number of students applying to college by nearly 10 percent at E. C. Glass High School and by 20 percent at Heritage High School. Placement tests for Central Virginia Community College which were offered at each high school, increased the early numbers of students taking the exam.

The next goal of the Beacon of Hope is to find and provide financial resources for students in need. In addition, they hope to

- become more identifiable as a source for the college application process,
- provide greater promotion of the college boards for tenth and eleventh grade students,
- make resources and information regarding trade, technical, and certification programs accessible and relevant to all students,
- increase efforts and opportunities for parents to understand and engage the college application and FAFSA process,
- increase efforts with mentoring programs, and
- increase efforts to gain faculty support and awareness of what the Beacon of Hope has to offer.

Mrs. Hamilton is to provide additional information about the Memorandum of Understanding between the Beacon of Hope and the school board during the retreat in July.

G-2. School Board Policy 5-49: Licensed Personnel: Conditions of Employment

During the recent Virginia General Assembly session, changes were made to the Code of Virginia §22.1-303 which affects the probationary period for new teachers. The new law, which is effective July 1, 2013, indicates the probationary term of service shall be for at least three years and that local school boards may have the option of extending this period to five years.

The Virginia School Boards Association and the Virginia Association of School Superintendents endorse extending the probationary term to five years, and area superintendents are recommending this to their respective school boards. School Board Policy 5-49: Licensed Personnel: Conditions of Employment reflects this change.

Mr. Copeland explained that the VSBA has developed a policy regarding this matter, and that policy was inserted into the school division's current policy and the former language was stricken. Further, all of the code section in the policy has been stricken as the school administration is unsure of the changes to those codes since the policy has not been revised since 1998.

The school board will consider this item for action at the next school board meeting.
