Ms. Melissa Rogers, director of the STEP with Links program, provided the school board with a review of the Pauline F. Maloney STEP with Links program, which is named for the founder of the STEP with Links, Inc. She stated that the program began in the Lynchburg City Schools more than 28 years ago, and approximately 1,700 sixth grade students have been served since its inception. Striving to Enhance Potential (STEP) helps student with leadership skills and provides enrichment programs in core subject areas. The students served are nominated in fifth grade by representatives of the feeder elementary school. Each of the middle school programs conduct weekly meeting, but there are times during the year when all students meet as a group. During these meetings, students participate in programs that provide information about nutrition, healthy living, financial management, and career exploration. The program also contains a parental involvement component which includes several opportunities through the year for parents to participate in various activities.

Michaela Warrick provided remarks about her experiences as a student who participated in the STEP with Links program.

Mr. Ben W. Copeland, assistant superintendent of operations and administration, was introduced to the school board. C-1. School Board Policy 7-15: Student Attendance

During several community meetings which occurred this past spring, The Honorable Kenneth W. Farrar, who presides over truancy cases for the Juvenile and Domestic Relations Court, expressed concern about the number of days students miss before their case appears in court. Judge Farrar has asked the school administration to streamline the process so that charges are filed after a student has seven days of unexcused absences in hopes to decrease truancy for students.

The school administration has reviewed School Board Policy 7-15: Student Attendance and has made revisions to coincide with the Judge Farrar's suggestions. Those revisions appear as an attachment to this agenda report. School board members asked if parents would be allowed to submit excuses and notes for absences via email. The school administration will discuss this topic further and provide information about a process for this at a future school board meeting.

C-2. School Board policy 7-33.3: Student Uniforms

On July 10, 2012, the school administration provided information to the school board regarding Heritage Elementary School and Sandusky Elementary School, two schools that wish to be removed from the current school uniform policy. The school board requested that the school administration investigate the methods by which the schools collected data to document parents, students, and teachers were in favor of the removal of their schools from the policy. The school board also asked that the school administration recommend a revision to the policy that would allow schools to establish or remove the student uniforms without it having to be approved by the school board each time. During this presentation, the school administration stated that each school did engage its school community in making the decision to exit the school uniform policy. The comprehensive plan does not include uniforms as one of its indicators for excellence; however, if the principals wish to use that as an option in its school improvement process, they may do so. Lynchburg City Schools has had a tradition of excellence with and without uniforms. Community engagement regarding this decision will continue as it has in the past, and principals will continue to make decisions in the best interest of their school community.

C-3. Lynchburg City Schools Comprehensive Plan

The school administration presented a draft copy of the Lynchburg City Schools Comprehensive Plan to the school board during its annual retreat, which occurred on July 26-27, 2012. As a result of the discussions that occurred during the retreat, the school administration has made changes to the comprehensive plan and presented those changes to the school board. Dr. Brabrand explained that this is the framework and foundation for continuous improvement in the Lynchburg City Schools.

The comprehensive plan is divided into five sections: Achievement, Behavior, Culture, Operations, and Personnel. Within each section, there are indicators of excellence with strategies and evaluative methods to determine if goals are met. Dr. Brabrand provided a brief overview of the comprehensive plan and explained that due to changes in staff, the Operations and Personnel sections of the plan will be presented in September. Further, Dr. Brabrand plans to provide a quarterly update to the school board.

Further, internal audits assisted officials and management in carrying out their responsibilities by appraising the effectiveness, efficiency, and accurateness of activities and programs.
