D-3. Capital Improvement Plan: Heritage High School

Mr. Copeland provided the school board with a review of the current site plan which includes one change regarding the student parking lot. The parking lot grade has been reduced by five feet, which will save approximately \$1.5 million. He also noted that at the beginning of the project, it was projected that the school would open in 2018 with a bid date of 2015. Since that time, it has been confirmed that there will be a bid date of 2014 with an opening of 2017. There will be no savings as the architects had been basing costs on a 2014 bid date.

Mr. Bill Downey, managing principal and Mr. Joe Adams, primary project manager, both of Downey and Scott, presented an analysis of the costs associated with the project. They estimate that the hard construction costs are \$70,143.943 and soft construction costs of \$13,951,453, for a total of \$84,095,396. This works out to be \$173.33 per square foot for 276,430 feet. There is a three percent contingency for total construction cost and a five percent scope contingency on the estimated amount. Site development presents the biggest problem as there is a need to bring in fill dirt and construct a large number of retaining walls. This firm, along with representatives from Moseley Architects, will present information about the Heritage High School project to the Lynchburg City Council in October.

E-1. Virginia School Boards Association and Norfolk Public Schools Suit to Invalidate OEI Legislation

The Virginia School Boards Association (VSBA) and Norfolk Public Schools have filed a suit in the Circuit Court for the City of Norfolk requesting that the Court invalidate the legislation enacted during the 2013 Session of the Virginia General Assembly that created the Opportunity Educational Institution (OEI) and the Opportunity Educational Institution Board. The joint press release issued by VSBA and Norfolk Public Schools appears as an attachment to this agenda report.

In an effort to support this action, the VSBA has developed a resolution for local school boards to consider. That resolution also appeared as an attachment to the agenda report. During this presentation, the school board discussed the suit filed by the VSBA and Norfolk Public Schools and the resolution.

The sample resolution is as follows:

SAMPLE RESOLUTION

RESOLUTION XYZ SCHOOL BOARD

WHEREAS, in its 2013 session, the General Assembly enacted legislation, which was subsequently approved by the Governor, creating the Opportunity Educational Institution (OEI) and the Opportunity Educational Institution Board; and

WHEREAS, the legislation mandates that the OEI Board take over the supervision and operation of any local public schools that have been denied accreditation and authorizes the OEI Board to take over any local public school that has been accredited with warning for three consecutive years; and

WHEREAS, it is the firm conviction of the School Board that this legislation violates the Constitution of Virginia in that it usurps the role of local school boards in supervising and managing the public schools of the Commonwealth; now therefore;

BE IT RESOLVED, the XYZ School Board hereby supports the lawsuit brought forth by the Virginia School Boards Association and Norfolk City School Board to declare the OEI legislation unconstitutional and to enjoin the OEI Board from taking any action to implement the legislation.

Dr. Brabrand provided remarks about the opening of school and renovations at Carl B. Hutcherson Building. Hutcherson now contains programs for prekindergarten, elementary alternative education, and the Parent

Center. Operations for secondary alternative education are now housed at the Fort Hill Community School, and the fence for that building is almost completed. Further, Dr. Brabrand stated that he is very proud of our teachers, administrators, and counselors who started this year with warmth and then competence.

Dr. Brabrand had the opportunity to attend the Beacon of Hope board meeting and learned that Elliot and Rosel Schewel had given the organization a \$100,000 challenge grant. He also learned today that the school division has been awarded \$100,000 from the 2013-14 School Security Equipment Grant Program. The funds will provide security cameras for all of our elementary schools.

Dr. Brabrand announced that the enrollment is 8,255, which is up from this time last year.
