The Lynchburg City School Board met for its regular meeting at 5:30 p.m. in the Board Room at the School Administration Building. Mr. White opened the meeting and requested that those in attendance stand and recite *The Pledge of Allegiance.*

A-1. Public Comments

In accordance with School Board Policy 1-41: Public Participation, the school board welcomes requests and comments as established in the guidelines within that policy. Individuals who wish to speak before the school board shall have an opportunity to do so at this time.

There were no individuals who wished to speak before the school board.

B-1. Sandusky Middle School: LEED Certification

The Sandusky Middle School project earned Leadership in Energy and Environmental Design (LEED) certification as a result of 31 documented and approved rating points under the LEED for Schools rating system. During this presentation, representatives from Dominion Seven Architects provided the school board with a brief review of the items included in the construction project which constitute LEED certification which are water efficiency, energy and atmosphere, materials and resources, and indoor environmental quality. The school board was also presented with a LEED certificate, which will be hung at Sandusky Middle School.

B-2. Dunbar Memorial Wall Committee

During the beginning phase of the Dunbar Memorial Wall, members of the memorial wall committee requested that a strip of land be made available at the original Dunbar High School site for the construction of the wall. Now that the project is complete, the Dunbar Memorial Wall Committee would like to return the strip of land to the school board.

Ms. Mary H. Payne and Mr. Wistar Withers, representatives of the committee, stated that two years ago, members of the Dunbar High School alumni decided that a memorial needed to be established in honor of the old Dunbar High School. As a result, a memorial has been erected on the site that contains the names of alumni and teachers who attended or taught at that school before its closure in 1970. To show its appreciation to the school board for its support of the memorial wall project, the committee presented the school board with a plaque containing a picture of Dunbar High School and the Dunbar Memorial Wall.

Mr. White thanked the committee for the plaque and for their work in ensuring that the school and those community members who attended and taught there would be remembered in this lasting and meaningful way.

B-3. Partners In Education

Mrs. Amy D. Huskin will be assuming the responsibilities associated with the Partners In Education program. During this presentation, Mrs. Huskin provided information about how the board of directors and the Lynchburg Regional Chamber of Commerce will use the school division's comprehensive plan to engage community members in participating in the Partners In Education program.

B-4. School Improvement Plan: Heritage Elementary School

The superintendent has directed each school within the school division to form a School Improvement Planning Team that will develop school improvement plans that identify areas for growth and improvement specific to their students' academic, behavioral, and cultural needs. During this presentation, Mrs. Sharon J. Anderson, principal at Heritage Elementary School, and members of her staff reviewed each section of the school improvement plan and outlined the various goals and strategies in place for achievement, behavior, and culture.

The revenue and expenditure reports detailed the transactions recorded through September 30, 2012. All reports appeared as attachments to the agenda report.

Mr. Beckles reported that the annual school report has been completed and filed with the Virginia Department of Education. The conversion of all staff to the vision and dental plans has also been completed. The financial audit fieldwork has also been completed, and the management letter contains no findings for this year. The audit regarding the schools and city's health benefits is ongoing.

Following the audit, it has been determined that there is a fund balance of approximately \$2.1 million. The school administration has determined several areas where this funding can be spent and will present a formal recommendation to the school board for its consideration. Following school board approval, a formal request will be presented to the Lynchburg City Council.

G-1. Bus Driver Retention Bonus

The school administration has been evaluating the 2013-14 salary scales. As a result of that evaluation, it has been determined that school bus drivers are not compensated at a level equivalent to surrounding school divisions or other organizations in Lynchburg. To attract new bus drivers and retain the quality bus drivers who have served the Lynchburg City Schools for many years, the school administration would like to offer a retention bonus this year to bus drivers as an incentive to remain and/or seek employment as a bus driver.

During this presentation, the school administration presented the proposed communication that will be sent to eligible bus drivers and request school board approval of the bonus. That communication is as follows:

SUBJECT: Retention Bonus

In an effort to show our appreciation to the bus drivers in Lynchburg City Schools, we are evaluating the 2013-14 salary scales and working to adjust compensations in a manner that will not only attract new drivers to LCS, but to retain the quality drivers that have supported us for many years.

To address our most immediate issue of retaining current drivers while attracting new drivers to LCS, we will be offering a one-year tiered retention bonus for our drivers. Any driver that is employed with the Lynchburg City Schools at the issue of this notice and is still employed on December 20th, 2012, will receive a \$300 bonus. Drivers that remain with LCS until May 30, 2013, will receive an additional \$500. If at anytime during this period, you should leave the employment of Lynchburg City Schools, this offer will no longer apply, even if you return at a later date before the end of school.

Please sign below stating that you understand that in order to qualify for the retention bonuses, you must have uninterrupted service as a driver for Lynchburg City Schools, from October 8 - December 20, 2012 (\$300 bonus), and from January 3 - May 30, 2013 (\$500 bonus). I also understand that if I am employed for only a portion of this time, I will not receive any percentage of the bonus being offered for that period of time.

It was noted that 27 drivers have left since the beginning of the school year.

Upon MOTION by Mrs. Barker, SECONDED by Ms. Waller, the school board approved the bonus options for school bus drivers to receive \$300 if there is uninterrupted service from October 17 – December 20, 2012, to be issued on December 28, 2012, and an additional \$500 to those who remain from that time until May 30, 2013.
