E. Student Representative Comments

Ms. Mia I. Brandon, student representative pro tem for E. C. Glass High School, and Miss Angelica M. Walker, student representative for Heritage High School, shared comments about events and activities occurring at their schools.

F-1. Lynchburg City Schools Comprehensive Plan: Operations and Personnel Update

During this presentation, Mr. Copeland provided information about the customer service survey that has been administered for the past two years. It was noted that with the addition of a night shift for maintenance, work orders are being filled at a higher rate. This is due to maintenance staff having the ability to complete work orders without having to wait until a classroom is empty or until students are not present which is consistent with the new strategy to implement work schedules to effectively utilize non-instructional time for maintenance tasks. Other highlights include:

- -Work Vehicles issued to all maintenance technicians;
- -iPads issued to all maintenance technicians for more efficient work order processing;
- -Four maintenance technician positions added on 1:00 p.m. to 9:30 p.m. shift; and
- -Rescheduled nine staff members to 6:00 a.m. to 2:30 p.m. shift which now provides coverage from 6:00 a.m. 9:30 p.m.

A report was also given on year-to-day labor hours by purpose and energy usage by school.

Mrs. Gee gave a report of classified staff hired for the 2014-15 school year, which included instructional assistants, therapeutic educational assistants, bus drivers, clerical staff, and substitutes. Demographic information and degrees held by those staff members were also provided. The same information was given for new certificated staff which also included years of experience, college attended, degrees held, and gender and race.

Mr. Childress provided the school board with a revised copy of the technology section of the Lynchburg City Schools Comprehensive Plan which noted those items that have been achieved and deleted from the plan as well as new goals established.

F-2. Policy FFA Naming School Facilities and Policy KHZ-R Gifts, Donations, and Bequests

Policy FFA Naming School Facilities was presented to the school board at several previous meetings. This policy provides procedures for the naming of school division properties, portions of properties, gymnasiums, and fields. As a result of discussions during those presentations, the policy has been revised, and those revisions have been reviewed by legal counsel.

Regulation KHZ-R Gifts, Donations, and Bequests is referenced in policy FFA Naming School Facilities and, therefore, was discussed during this presentation.

Concerns were raised about the superintendent making decisions about items being presented to the school board regarding the naming of facilities, etc. The policy specifies that the superintendent should consult with the board chairman when making decisions about whether an item should come before the school board. Concerns were also raised about donations and gifts being raised to a higher amount before school board/superintendent approval. The amounts were raised to \$5,000 for school board approval, and \$1,000 for superintendent approval. Discussion also focused on procedures for the naming of scholarships. That language will be removed from the current regulation, and a new regulation will be developed for scholarships.

G-2. Capital Improvement Plan: School Administration Building

The 2014-15 capital improvement plan includes \$204,000 for replacement of the elevator in the School Administration Building. The City of Lynchburg Office of Procurement and Purchasing has received a total of six bids on the elevator project.

The school administration recommends CS Custom Structures, Inc. based on their bid of \$128,000 which was the lowest bid. All bids received are listed below.

G-4. XLR8 STEM Academy Budget: 2014-15

The Lynchburg City School Board serves as the fiscal agent for the XLR8 STEM Academy. The governing board of the school has approved its 2014-15 operating budget in the amount of \$276,750.00, which represents an increase of \$16,363.27 from the 2013-14 approved budget.

Funds expended at the XLR8 STEM Academy are totally reimbursable from participating school divisions and through grants or donations. School divisions which are members of the regional program are Amherst County Public Schools, Appomattox County Public Schools, Bedford County Public Schools, Campbell County Public Schools, and Lynchburg City Schools.

G-5. Central Virginia Governor's School for Science and Technology Budget: 2014-15

The Lynchburg City School Board serves as fiscal agent for the Central Virginia Governor's School for Science and Technology. The governing board of the school has approved its 2014-15 operating budget in the amount of \$1,025,592, which represents an increase of \$92,370 over the prior year budget of \$933,222. All funds expended at the school are totally reimbursable from participating school divisions and state funds as listed on the attached budget. School divisions supporting this program are Amherst County Schools, Appomattox County Schools, Bedford County Schools, Campbell County Schools and Lynchburg City Schools.

Provided below is the financial impact summary for the Lynchburg City Schools:
