A-1. Public Comments

B-1. Student Recognition

Two E. C. Glass High School Cross Country standouts swept the state championship individual titles this past November. Elizabeth (Libby) T. Davidson is a sophomore at the school, and she won her second consecutive state cross country individual title by breaking the course record in a time of 17 minutes and 12 seconds at the Group AAAA championship. Libby's year also included victories at the Knights Crossing and the Conference 24 championships.

Also, Peter D. Seufer, a senior at E. C. Glass High School, won the individual title with a time of 15 minutes and eight seconds, improving on his time last year from also a full minute. Both runners were invited to the national high school championships hosted and paid for by the Footlocker. Only 80 runners in the entire country are invited to this event.

G-1. Discretionary Grant Development Program

Mr. Jack B. Freeman, director of grants, provided the school board with an update of the discretionary grant program for the Lynchburg City Schools. Since joining the school division in 2013, Mr. Freeman has

- installed a process to identify, bid, and manage large grant programs;
- created a grant development presence on the LCS website;
- developed and published online a list of education-focused foundation grant opportunities;
- developed and published a grant project idea worksheet to help teachers and administrators develop grant project ideas;
- registered the school division with the federal System for Award Management in order to become eligible for federal grant awards;
- updated the school division's registration with primary grant submittal portal for federal bids; and
- developed and submitted three major federal proposals.

Mr. Freeman noted that while the three major federal proposal were not successful, it did help the school division learn how to become more successful when submitting future proposals. He also shared a list of grants that the school division has obtained over the past two years as well as a list of major opportunity forecast for 2014-15.

G-2. LAUREL Regional Program Budget: 2014-15

The Lynchburg City School Board serves as the fiscal agent for the LAUREL Regional School. The governing board of the school has approved its 2014-15 operating budget in the amount of \$5,280,181.00, which represents an increase of \$189,653.50 from the 2012-13 approved budget.

Funds expended at the LAUREL Regional School are totally reimbursable from participating school divisions and the Commonwealth of Virginia. School divisions which are members of the regional program are Amherst County Public Schools, Appomattox County Public Schools, Bedford County Public Schools, Campbell County Public Schools, and Lynchburg City Schools. The LAUREL Regional School provides services for students with severe disabilities. The following services are also provided by staff employed through LAUREL Regional School to identified students with disabilities at their schools: occupational therapy, physical therapy, vision services, and autism services.

G-3. Pauline F. Maloney STEP with Links Program Budget: 2014-15

The Lynchburg City School Board serves as fiscal agent for the Pauline F. Maloney STEP with Links program. The organization's governing board has approved its 2014-15 operating budget in the amount of \$45,539.00, which represents a decrease of \$1,164.00 over the 2013-14 fiscal year.

The Pauline F. Maloney STEP with Links program enhances academic and cultural development of minority students who are in the sixth grade and is sponsored by the Links, Inc., a national organization of professional women. The program is funded entirely through donations. Lynchburg City Schools contributes \$10,000 annually to this program.

Ms. Waller provided information about the LAUREL School Board meeting that she attended on December 3. She noted that Mrs. Donna D. Lewis is the third director of the program in as many years.

Dr. Coleman attended the Christmas program given by students at Heritage Elementary School, and he thanked Heritage High School for allowing the use of the building this performance.

Dr. Dolan-Sewell announced that there will be opportunities for school board members to participate on two school-related program boards. They are the STEP with Links Board and the Key Communicators Advisory Board. She will email board members to determine interest.

The school board will have regular school board meetings on January 6 and 20, 2015, and a budget work session on January 15, 2015.
