#### B-1. School Improvement Plan: Hutcherson Early Learning Center

The superintendent has directed each school within the school division to form a School Improvement Planning Team that will develop school improvement plans that identify areas for growth and improvement specific to their students' academic, behavioral, and cultural needs. Trent, principal at Hutcherson Early Learning Center, and members of her staff reviewed each section of the school improvement plan and outlined the various goals and strategies in place for achievement, behavior, and culture.

## C-1. Finance Report

The school administration, in accordance with the 2012-13 schools' operating budget, authorized, approved, and processed the necessary payments through November 30, 2012. The school administration certifies that the amounts approved are within budgetary limits and revenue.

The revenue and expenditure reports detailed the transactions recorded through November 30, 2012. All reports appeared as attachments to the agenda report.

Mr. Beckles stated that there are no major issues to report. He has received a copy of the governor's revised version of the biennium budget, and there is little change in revenue. Staff will attend a webinar regarding the budget on Wednesday. He will receive additional information about funding at that time.

The financial audit is complete, and school board members have received the city's CAFR. There were two comments: one indicating that one of our accountants resigned just prior to the audit, but that it had no affect on the outcome of the information that was provided to them in a timely manner; and two, the chief financial officer should not have access to the general ledger and financial accounts. The benefits audit continues, and issues found will be discussed with city and schools administration on December 21.

# F-1. School Culture Survey

Part of the Lynchburg City Schools Comprehensive Plan included administering a school culture survey to students, staff, and the community. The survey has been conducted, and the data has been tabulated. During this presentation, Ms. Ethel R. Coles, coordinator of equity and accountability, provided the school board with the data resulting from the division-wide survey. She noted that the purpose of the survey was to gather baseline date in an effort to determine our strengths and challenges surrounding school culture.

The survey was taken from the Virginia Department of Education self-study survey used for schools that are in improvement. The school administration has noted specific items where individual respondents requested that another indicator such as 'not applicable' would be helpful in completing the survey. Comments and school specific information has been shared with principals and will become part of their evaluation.

The results of the survey will be shared with all stakeholders. Division-level discussions will occur regarding strengths and challenges, and the development and implementation of professional development will occur by spring 2013. Further building-level professional development will also be developed and implemented by summer 2013.

## F-2. School Operating Budget: 2013-14

As part of the budget development process for FY2013-14, the school administration has conducted several community budget meetings in order to share information and receive comments about next year's budget. On November 27, 2012, that presentation was given to the school board. Following the presentation, school board members were able to provide comments about budget priorities and to discuss items that the school administration has suggested for possible inclusion for next year. Again on December 4, and December 12, the school board discussed and established priorities within the budget.

Dr. Brabrand began the discussion by noting that the governor has called upon all school divisions in the state to review safety procedures and identify resources needed to ensure that students and staff are safe and secure. In response to this announcement, the school division is initiating a comprehensive review of the safety procedures and protocols in place. As part of this review, the school administration will

- review existing school crisis policies and procedures in collaboration with the Lynchburg Police Department, Lynchburg Fire Department, and other public safety officials;
- establish a dedicated security, truancy, and check-in attendant for each elementary school;
- redeploy middle school SROs for 2013-14 in collaboration with the Lynchburg Police Department;
- upgrade classroom security capabilities including updated crisis plan training for all employees;
- provide crisis training scenarios facilitated by the Lynchburg Police Department;
- accelerate planned upgrades to visitor software tracking at every school as well as the addition of security vestibules at schools to provide additional restrictive access; and
- review security camera placement and equipment at all schools to ensure adequate coverage of key areas.

Dr. Brabrand notes that these items will require additional funding to implement.

Mrs. Bruce provided information about the gifted opportunities program in response to questions that were asked at the December 12, 2012, work session.

## Mrs. Poore returned at 7:27 p.m.

Additional information was also provided regarding the elementary alternative education program and responsibilities associated with the request for three social workers. The school board indicated that items on

tier one would be included in requests for the 2013-14 school operating budget. Tier two items would be relegated to the 2014-15 budget.

# G-1. Academic Calendar: 2013-14

The proposed 2013-14 academic calendar presented for discussion tonight includes:

- First day of student attendance as August 26, 2013
- 180 student instructional days
- Last day of student attendance as June 6, 2014
- 11 teacher professional development/planning dates
- Six early dismissal days to provide teachers with additional planning time
- Three orientation days for new teachers

This draft developed by the Calendar Committee, has been presented to the Superintendent's Personnel Advisory Committee, the Secondary Leadership Team, the Elementary Leadership Team, and during the December principals' meeting.

The calendar calls for new teachers to report on August 12, and all other teachers will report on August 15. The first student day is August 26. Early release days for all students will provide planning time, Professional Learning Communities meetings, and other professional development activities. Should the school division not receive a waiver to open prior to Labor Day, the calendar will begin one week later than currently scheduled.
