## Foundation Awards \$56,754 in Grants

The 20th annual Lynchburg City Schools Education Foundation, Inc.'s Education Grant Awards Program was held on May 9, 2012 at E.C. Glass High School. Forty-three educational grants were featured and Lynchburg City Schools' teachers and corporate sponsors were present to celebrate the success



and impact of these grants. The Foundation awarded \$56,754 in teacher grants for the 2011-2012 school year and has awarded more than \$329,000 in grant money to date. ## Message from the Executive Director

Thanks to the generous support of the Lynchburg community, the Foundation experienced another successful year with significant growth in many of our programs. We are indeed fortunate to live in a community that is committed to strong public education. With your support, we were able to increase our allocation of grant funding to teachers, increase our inventory for **Tools4Schools**, award scholarships, and recognize our seniors for academic success.

In addition to our 'signature' programs, the Foundation advocated for our schools by supporting the division's 'Get to Know Your Schools' open house and securing public support during the annual budget process. The Foundation was also able to step in where needed by bridging the financial gap for economically disadvantaged students registered in Dual Enrollment classes and presenting teachers at RS Payne with a \$2000 check to help them with immediate needs after significant water damage destroyed several classrooms.

Looking ahead to 2012-2013, the Education Foundation will launch our new logo which will give us an updated look. Our new logo will better reflect the ultimate goal of 'graduation' along with our desire to provide resources to not only support, but also advance, the Lynchburg City Schools.



In addition, our 'Teacher Grants' will now be called 'Classroom Innovation Grants' to better reflect the intention of this program. The goals and criteria are the same with just a more descriptive title.

The community's investment in our programs demonstrates the depths to which you value our teachers and students. It is an exciting time to be part of the Lynchburg school division. We hope you will continue to support the Foundation in our mission to support teachers and students as together we advance the Lynchburg City Schools.

## 50th Anniversary of Integration in the Lynchburg City Schools

2012 marks the 50th Anniversary of the 1962 integration of Lynchburg City Schools. In commemoration of this historic period for our city, Lynchburg City Schools hosted Dr. Virgil Wood., educator and civil rights activist, to speak to our community. Dr. Wood has committed much of his life's work to the struggle for economic development among the nation's disadvantaged. His untiring work and the pivotal role he served in the integration of Lynchburg City Schools provided students with a unique opportunity to hear directly from an icon of living civil rights history. Dr. Wood's influence in bringing Dr. Martin Luther King, Jr. to Lynchburg and leading Dr. King's work via the Lynchburg Improvement Association helped lay the foundation for decades of student diversity within our classrooms. The Lynchburg City Schools Education Foundation is proud to have had the opportunity to work with the school division and the Greater Lynchburg Community Trust to facilitate the necessary funding to bring Dr. Wood to our community and the programs created to mark this historic event.
